The Department of Environmental Protection's (Department) Division of Sustainable Waste Management is in receipt of an August 24, 2023, request for administrative action to the Monmouth County District Solid Waste Management Plan (County Plan). This request for administrative action to the County Plan proposes County Plan inclusion of operational changes at Greenway Industries of New Jersey T/A Greenway Recycling Class B Recycling Center, located at 89 Yellowbrook Road, Block 177 Lot 62.01 in the Township of Howell. Specifically, the August 24, 2023 request for administrative action to the County Plan proposes County Plan inclusion of:

- Changes to hours of operations:
  - The operating hours of the facility have changed from 7:00a.m. to 5:00p.m. to twenty-four (24) hours a day Monday through Friday. The extended hours are for material receipt and transfer only, not processing.
  - Saturday hours will remain the same from 8:00am - 4:00pm.
- Acceptance of up to 2,000 tons per day with a maximum limit of 6,000 tons per week of Class B recyclable materials, including concrete, concrete pipe, concrete block, other concrete materials and asphalt at the facility.

Pursuant to N.J.A.C. 7:26-6.11(b)5, the Department considers this County Plan inclusion of the above noted operational changes at Greenway Industries of New Jersey T/A Greenway Recycling Class B Recycling Center to be an approvable administrative action. Therefore, this administrative action is hereby approved pursuant to N.J.A.C. 7:26-6.11(f).
