The Department of Environmental Protection's Division of Solid and Hazardous Waste is in receipt of a proposed amendment to the Morris County District Solid Waste Management Plan (County Plan) dated January 28, 2020. This amendment to the County Plan proposes County Plan inclusion of revised hours of operation for waste acceptance and processing at the two (2) Morris County Municipal Utilities Authority's (MCMUA) Transfer Station/Materials Recovery Facilities (TS/MRF) located in the Township of Mount Olive and the Township of Parsippany-Troy Hills. Specifically, the revised hours of operation are included in the County Plan as follows:

Township of Mount Olive TS/MRF:

• Acceptance of waste: Monday through Friday: 7:30 a.m. to 4:30 p.m.

Saturday: 7:30 a.m. to 1:30 p.m.

• Processing of waste: Monday through Friday: 7:00 a.m. to 6:00 p.m.

Saturday: 7:00 a.m. to 3:00 p.m.

Township of Parsippany-Troy Hills TS/MRF:

• Acceptance of waste: Monday through Friday: 7:00 a.m. to 4:00 p.m.

Saturday: 7:00 a.m. to 11:00 a.m.

• Processing of waste: Monday through Friday: 7:00 a.m. to 6:00 p.m.

Saturday: 7:00 a.m. to 3:00 p.m.

Pursuant to N.J.A.C. 7:26-6.11(b)14, the inclusion of revised hours of operation can be accomplished via an administrative action. Therefore, the County Plan inclusion of the revised hours of operation at the two (2) MCMUA TS/MRFs are hereby approved as an administrative action pursuant to N.J.A.C. 7:26-6.11(f).
