The Department of Environmental Protection's Division of Solid and Hazardous Waste is in receipt of a request for administrative action to the Passaic County District Solid Waste Management Plan (County Plan) dated March 3, 2017. Administrative Action 001-17 to the County Plan proposes County Plan inclusion of designated traffic routes for solid waste vehicles accessing the Coastal Distribution of Paterson, LLC Transfer Station/Materials Recovery Facility (TS/MRF), located at 30-36 Fourth Avenue in the City of Paterson. Specifically, the March 3, 2017 request for administrative action to the County Plan proposed County Plan inclusion of three traffic routes for solid waste vehicles accessing the facility:

1. Option #1 – Route 208/Route 4

From Route 208 North or South: Exit at Maple Avenue, Paterson. Take Maple Avenue southbound approximately  $\frac{3}{4}$  of 1 mile. Cross over bridge and bear right. Take First Avenue 4 blocks to River Street. Make left on River Street and proceed approximately  $\frac{1}{4}$  of 1 mile to Fourth Avenue. Make right on Fourth Avenue. Coastal is located on the left side at the railroad crossing.

2. Option #2 – Route 80

From Route 80 westbound: Take Exit 60 to Route 20 North approximately 3 miles to First Avenue. Make left on First Avenue and proceed four blocks to River Street. Make left on River Street and proceed approximately  $\frac{1}{4}$  of 1 mile to Fourth Avenue. Make right on Fourth Avenue. Coastal is located on left side at railroad crossing.

From Route 80 eastbound: Take Exit 57B to Route 19 North Downtown Paterson. Make left on Main Street and proceed seven blocks to River Street. Make right on River Street. Take River Street northbound for approximately 1 and  $\frac{1}{2}$  miles to Fourth Avenue. Make left on Fourth Avenue. Coastal is located on left side at railroad crossing.


3. Option #3 -- Route 95

From Route 95 North: Take Exit 17 to Route 80 westbound. Take Exit 60 to Route 20 North approximately 3 miles to First Avenue. Make a left on First Avenue and proceed 4 blocks to River Street. Make left on River Street and proceed approximately ¼ of 1 mile to Fourth Avenue. Make right on Fourth Avenue. Coastal is located on left side at railroad crossing.

Pursuant to N.J.A.C. 7:26-6.11(b)2, the inclusion of designated traffic routes for solid waste vehicles accessing a solid waste facility can be accomplished via an administrative action. Therefore, the County Plan inclusion of designated traffic routes for solid waste vehicles accessing the Coastal Distribution of Paterson, LLC TS/MRF is hereby approved as an administrative action pursuant to N.J.A.C. 7:26-6.11(f).
