Dear Ms. Seiden:

The Department of Environmental Protection's Division of Solid and Hazardous Waste is in receipt of a request for administrative action to the Passaic County District Solid Waste Management Plan (County Plan) dated August 24, 2015. Administrative Action 002-15 to the County Plan proposes County Plan inclusion of additional parcels as parts of the Gaeta Recycling Company, Inc. Transfer Station/Materials Recovery Facility (TS/MRF), located at 278-282 West Railway Avenue and the Class A Recycling Center, located at 189-195 Genessee Avenue, both in the City of Paterson. Specifically, Administrative Action 002-15 to the County Plan proposes County Plan inclusion of the following parcels in the City of Paterson as parts of the Gaeta Recycling Company, Inc. TS/MRF and Class A Recycling Center:

- o Block 7006; Lot 16
- o Block 7003; Lot 1 described as 88-100 Michigan Avenue
- O Leased parcel from Norfolk Southern Railway Company, Inc. A more detailed narrative is further described as 0.38 acres of land for truck and trailer parking and equipment storage at Milepost 14.2 Line Code 6168 in the City of Paterson, NJ. This parcel is a portion of Block 7120; Lot 1, located along West Railway Avenue, approximately bounded by Gould Avenue and Grove Street.

In summary, in addition to above, the following parcels are included in the County Plan for the Gaeta Recycling Company, Inc. TS/MRF and Class A Recycling Center:

- o Block 7005; Lots 2, 3, 4 & 5
- o Block 7006; Lots 1, 2, 3, 17, 18, 19 & 20
- o Block 7118; Lots 2 & 3

Pursuant to N.J.A.C. 7:26-6.11(b)5, the inclusion of additional parcels of land to an existing solid waste facility and/or recycling center can be accomplished via an administrative action. Therefore, the County Plan inclusion of the above identified parcels in the City of Paterson as parts of the Gaeta Recycling Company, Inc. TS/MRF and Class A Recycling Center is hereby approved as an administrative action pursuant to N.J.A.C. 7:26-6.11(f).
