The New Jersey Department of Environmental Protection's Division of Sustainable Waste Management, Bureau of Solid Waste Planning and Licensing is in receipt of a proposed amendment to the Passaic County Solid Waste Management Plan (Plan) dated November 7, 2024. This amendment to the Plan proposes plan inclusion of a change in name for three Covanta Sustainable Solutions, LLC facilities. The new names are included below:

- Covanta Sustainable Solutions, LLC - Fulton Street will now be named Reworld Sustainable Solutions - LLC - Fulton Street, located at 20-32 Fulton Street, Block 3115, Lots 5 and 17 in the City of Paterson.
- Covanta Sustainable Solutions, LLC - River Street will now be named Reworld Sustainable Solutions – LLC - River Street, located at 178 River Street, Block 3016, Lots 2, 8, 9, 10, 11, 12, and 13 in the City of Paterson.
- Covanta Sustainable Solutions, LLC - Totowa will now be named Reworld Sustainable Solutions – LLC - Totowa, located at 301 Maltese Drive, Block 170.02, Lot 3 in the Borough of Totowa.

Pursuant to N.J.A.C. 7:26-6.11(b)14, the inclusion of a facility name change in the Passaic County Solid Waste Management Plan can be accomplished via administration action. Therefore, the County Plan amendment is hereby approved as an Administrative Action pursuant to N.J.A.C. 7:26-6.11.
