The Department of Environmental Protection's Division of Solid and Hazardous Waste is in receipt of a request for administrative action to the Cape May County District Solid Waste Management Plan (County Plan) dated March 27, 2018. The subject request proposes County Plan inclusion to modify the existing hours of operation of both the Cape May County Municipal Utilities Authority (CMCMUA) Secure Sanitary Landfill and Transfer Station.
