

Nearly 25% of All Violations Issued to Hazardous Waste Generators Are For Failing to Properly Label Containers

The following information from the New Jersey Department of Environmental Protection (DEP) can help hazardous waste generators avoid violations. However, it does **not** include all applicable regulations.

 When hazardous waste is generated, immediately mark the accumulation container with the words "Hazardous Waste" and the date waste accumulation began. Use a permanent marker or paint, or write the information on a pre-printed or handmade label, as shown below.





2. Large-quantity generators of hazardous waste are allowed to accumulate hazardous waste on site for a maximum of 90 days, starting from the date waste accumulation began, as marked on the container. By law, any large-quantity generator storing hazardous waste beyond the 90-day time frame is determined to be operating a hazardous waste storage facility and must obtain a Resource Conservation and Recovery Act (RCRA) Treatment, Storage or Disposal Permit. Small-quantity generators are allowed to accumulate hazardous waste on site for a maximum of 180 days. Any small-quantity generator storing hazardous waste beyond the 180-day time frame is required to obtain a RCRA Treatment, Storage or Disposal Permit.

- 3. If a generator fails to include the accumulation start date when labeling containers, the DEP will be unable to ascertain compliance with the above-noted permit exemption rule, and the generator could be determined to be operating a hazardous waste storage facility without the required RCRA Treatment, Storage or Disposal Permit.
- Large-quantity generators are required to inspect areas where hazardous wastes are accumulated weekly. This inspection should be recorded in a written log, and should include information on labeling, dating, and number of containers and condition of containers.
- 5. Special marking is required for materials such as used oils, universal wastes and other recyclable materials. For used oil, mark accumulation containers and tanks with the words "used oil." Universal waste, as it is accumulated, must be marked with the words "recyclable materials" and either "Universal Waste Batteries", "Universal Waste Mercury-Containing Devices", "Universal Waste Oil-Based Finishes", "Universal Waste Pesticides", "Universal Waste-Consumer Electronics" or "Universal Waste-Lamps," as appropriate. The collection date of this material is also required.
