DEP to Present Free Seminar on Universal Waste and EPA's New Rule – The Definition of Solid Waste

Who is affected by this initiative?

Hazardous Waste Generators, Transporters and Treatment Storage and Disposal Facilities should find the presentation on the Definition of Solid Waste Rule quite informative. Universal Waste Generators, Handlers, Transporters and Destination Facilities are encouraged to attend this event.

Why would I need help?

On December 29, 2008 EPA's new <u>Definition of Solid Waste Rule</u> became federally effective. New Jersey adopted this rule by reference in early 2009. Under this rule, certain materials that were once handled as hazardous waste (solvent wastes for example) may now be eligible to be handled as a hazardous secondary material with reduced regulatory requirements. You may have heard about this rule, and are considering handling some of your current hazardous waste as an exempt hazardous secondary material. If you are considering this change you should attend this seminar. You will be provided with the information required to consider taking advantage of this exemption and keep your company in compliance. The subject will be presented by USEPA staff involved in the original promulgation of the rule change.

The presentation on <u>Universal Waste</u> provides a focused emphasis on the subject. It is full of valuable information for all Universal Waste Small Quantity Handlers, Large Quantity Handlers, Transporters and Destination Facilities. The presentation includes a general lecture on understanding the regulations, followed by talks from an industry representative and a NJDEP inspector. It concludes with a panel discussion to answer all your questions.

What compliance assistance is available?

The Bureau of Hazardous Waste Compliance & Enforcement will be providing this Seminar free of charge on **June 16, 2010**. This seminar will provide a thorough overview of EPA's new Definition of Solid Waste Rule and State and Federal Universal Waste Rules.
