NJDEP A-901 UPDATE RENEWALS

Who is affected by this initiative?

All approved A-901 Licensees and all A-901 Applicants.

All applicants and licensees who meet the A-901 Licensing requirements by having an Integrity Review by the New Jersey State Police and Attorney General's Office receive an approved 'License' to transport solid and hazardous waste or broker in New Jersey. A requirement of the license is that all A-901 applicants, licensees, and Second Level business entities submit an Annual Update of their Business Concern Disclosure statement no later than November 1st each year. Failure to complete and submit the Annual Update may result in the revocation or denial of the A-901 license or application.

Why is DEP requiring the Annual Update?

Pursuant to <u>N.J.A.C</u>. 7:26-16.6, all A-901 applicants, licensees, and Second Level business entities are required to submit a yearly Update. 2012 Updates were to be submitted no <u>later</u> than **November 1, 2011.**
