Upcoming FREE Air Compliance & Enforcement (ACE) Training/Outreach Seminar

Who would benefit from attending this compliance assistance event?

Anyone who is interested in learning about or who is subject to NJDEP's Air Pollution regulations is encouraged to attend.

Seminar Description:

This training will provide information on multiple air pollution topics. The event will begin with a brief update on current efforts within our Air program, followed by an update on the new General Permits. The event will continue with an overview of the Non-Technical Amendment, and how one goes about completing and submitting the form. Do the terms NOV, AONOCAPA, ACO have you confused? We will also provide an overview of all Enforcement Documents.

The morning will wrap up with a presentation on applicable regulations and requirements for area source emergency generators. In the afternoon we will be focusing on electronic reporting which will include a presentation from the Bureau of Technical Services as well as a step by step instructional on submitting reports through the NJDEP Online Portal for General Permits, Annual Combustion Adjustments and Title V Reports. The day will conclude with a question and answer session.
