Find Your Unpaid Pesticide License or Product Invoice Online

Who is affected by this advisory?

All New Jersey Pesticide License Holders and Product Registrants including:

- Commercial Applicators and Operators
- Commercial Applicator Businesses
- Dealers and Dealer Businesses
- Pesticide Product Registrants

Why is DEP issuing this advisory?

In a continuing effort to streamline online payment processes, DEP is providing outreach to licensed commercial pesticide applicators, operators and businesses, pesticide dealers and dealer businesses, and pesticide product registrants by announcing new online reports that provide immediate access to unpaid license and product registration invoice information. These are additional tools that allow for timely, online payment of outstanding invoices. Individual invoice numbers with corresponding unpaid invoice amounts are now available on website links and are accessed using license or PI (Program Interest) numbers.

What should I do?

Unpaid pesticide invoice history is available via our website: www.pcpnj.org. On this page click on the link for "Pesticides". Then, under the "Online Payments and Reports" heading, choose the appropriate report or payment option:

- Pay and Process Product Registrations Online
- Look Up Your Product Invoice Number
- Pay For Your License Online
- Look Up Your License Invoice Number

What is DEP doing?

DEP is supplying the regulated community with easy access to their individual unpaid pesticide invoice history via website links. These report links enable direct payment to the DEP for outstanding pesticide license and/or product registration invoices. This allows for immediate, online payment processing resulting in a quicker, more secure payment process that is available 24/7.
