



## **DEP to Present Free Seminar on the New Hazardous Waste Rules**

### **Who is affected by this initiative?**

Hazardous Waste Generators, Transporters, Treatment Storage and Disposal Facilities, Regulated Medical Waste Generators, LSRPs (Licensed Site Remediation Professionals) and Environmental Consultants should find this seminar helpful in maintaining compliance with the Hazardous Waste regulations.

### **Why would I need help?**

The EPA Administrator signed the final Hazardous Waste Generator Improvements Rule on October 28, 2016. This rule update significantly changed the Hazardous Waste Rules for Generators. The State of New Jersey adopted the rule in its entirety on May 30, 2017.

EPA's goals with this rule update are to make the Hazardous Waste Rules easier to understand, to facilitate better compliance, to provide greater flexibility in how hazardous waste is managed and to close gaps in the regulations. It allows some generators to avoid moving to a higher generator status when generating episodic waste. It also allows Very Small Quantity Generators to send their hazardous waste to a Large Quantity Generator that is under control of the same entity. This revised rule should enhance safety of facilities, employees and the public by improving hazardous waste communication and by ensuring that emergency management requirements meet today's needs.

### **What compliance assistance is available?**

On **May 23, 2018**, the New Jersey Department of Environmental Protection's Compliance & Enforcement Program will present a **free seminar** on the Generator Improvements Rule.
