## Frequently Asked Questions

### What is the annual hazardous waste generator fee and how was the amount determined?

Hazardous Waste (HW) generator fees are based upon the **total amount of HW manifested within a calendar year**. See below:

HW Generator Classification	Annual HW Generated	Annual Fee
Large Quantity Generator	26,400 pounds or more of hazardous or 2.2 pounds or more of acutely hazardous waste	\$ 970
Small Quantity Generator	Between 2,640 and 26,400 pounds of hazardous waste	\$ 835
Very Small Quantity Generator	Less than 2,640 pounds of hazardous waste (including for zero hazardous waste while remaining registered)	\$ 30

# Generator Fee Verification




- Provides compliance assistance
