Workshop Overview:

This workshop is offered to youth take a kid pheasant hunt participants who are new to shotgun handling and shooting. Participants will learn about proper gun fitting, basic shotgun shooting mechanics and firearm safety from NCSA-qualified Griffin & Howe instructors. This workshop is a two-day event and will be held on September 26 and October 3, 2021. There are 2 time slots available: 10:00 am – 12:00 pm and 1:00 pm – 3:00 pm.

Workshop Fee:

Facilities:

The Griffin & Howe Shooting Academy welcomes New Jersey youth hunters to experience a lesson at their state-of-the-art facility at Hudson Farms. The Hudson Farm Club is a leader in innovative conservation practices and operates The Hudson Farm Foundation which makes annual disbursements to local charities in the community.

All participants must provide their own ear and eye protection. Firearms can be provided upon request. **All ammunition** will be provided. Participants and accompanying adult must come dressed in semi-formal attire; including but not limited to khakis, dress pants, button up shirt, or polo. Blue jeans and tee-shirts are not permitted.
