When was the last time you cleaned your firearm?

We're all guilty. Used hard, put away dirty, random regret and sudden urge to clean every firearm in the safe. Read below to find out how you can keep your firearm in tip top shape for generations to come.

How often should you clean your gun?

Ideally, you should clean your gun after each day of use. Sometimes this is not practical, so the rule of thumb is to never discharge a firearm that hasn't been cleaned after prolonged storage. So, what does this mean for the weekend pheasant hunter? Or the average turkey hunter? If you forget to clean your gun after a season is over, take the time to prep pre-season. It could save you a few fingers. Accumulated moisture or dirt could affect the gun's performance or worse, could be hazardous.

What to use:

Breaking down and cleaning your firearm may be a daunting task, but new innovative tools and supplies have made it easier than ever before!

Cleaning Rod with Attachments allows you to reach inside the barrel and remove dirt and residue with a number of different attachments; cloth swab, patch holder, and wire brush.

Bore Snake is an all-in-one cleaning machine. This is not suggested to use before prolonged storage. Bore ropes feature enough material to complete the initial swab, wire brushing, and final swab in just one pull of a rope.

Gun Cleaning Solvent's are used to break down the carbon fouling, copper, lead, unburned powder, and other debris that can get stuck on or in your firearm.



Monthly Fun Fact:

The Pittman-Robertson Act was signed by President Franklin D. Roosevelt on September 2, 1937. This act officially know as the Federal Aid in Wildlife Restoration Act of 1937, commandeers an existing 11-percent excise tax on rifles, shotguns, and ammunition, and a 10-percent tax on pistols. The act has earmarked this money for the Department of the Interior and its wildlife preservations efforts.
