### Notice of Public Meeting

PLEASE TAKE NOTICE that, pursuant to N.J.A.C. 7:36-26.6(c), the County of Atlantic will hold a public hearing for the purpose of providing information and soliciting the input of the general public regarding a proposal to divert approximately 1000.1 square feet of property known as Block 1933, Lot 1, Block 1934, Lot 1, and Block 1934, Lot 2 on the official tax map of Egg Harbor Township, in connection with safety improvements at the intersection of Spruce Avenue and West Jersey Avenue within the Atlantic County Bikeway. The proposed improvements will result in a net decrease of impervious surface along the affected property.

All information submitted by Atlantic County to the Green Acres Program in support of this proposed diversion is available for public inspection at the Egg Harbor Township Municipal Office, Atlantic County Library, Egg Harbor Township branch, and the Green Acres Program Office.

A hearing to obtain public comment on this proposal will be held at 6pm on Wednesday, May 4, 2011 at the Atlantic County Canale Training Center, 5033 English Creek Avenue, Egg Harbor Twp, NJ. Written comments on the proposal may be submitted to the Atlantic County Department of Regional Planning, P.O. Box 719, Northfield, NJ 08225-0719, Attention: Joseph Maher, at any time during the public comment period which shall close two weeks after the date of the Public Hearing.
