To Whom It May Concern:

This letter is to provide you with written notification that the Township of Cherry Hill, located at 820 Mercer Street, Cherry Hill, NJ 08002, will hold a public hearing to obtain comments regarding its application to the NJDEP Green Acres Program, for the proposed minor diversion of parkland owned by the Township. This application is subject to NJDEP Commissioner and State House Commission approval, and is available for review at the Cherry Hill Township Municipal Clerk's Office located at 820 Mercer Street, Cherry Hill, NJ 08002, Room 107 and the Cherry Hill Public Library located at 1100 Kings Highway North, Cherry Hill, NJ 08034 and at the NJDEP Green Acres Program offices (address below).

The public hearing will be held on:

Tuesday, October 1, 2019 at 6:00 pm Croft Farm Art Center 100 Bortons Mill Road, Cherry Hill, NJ 08034.

All interested parties are invited to attend and participate in the public hearing. In addition to the oral comments presented during the hearing, written comments may be submitted to the agencies listed below. All written comments must be received within two weeks following the hearing by Tuesday, October 15, 2019.

The proposed parkland diversion would involve the taking of approximately .23 acres of parkland located at Block 408.01, Lot 1 for the introduction of a Right Turn Lane along Kresson Road (CR 671) westbound at the intersection of Brace Road (NJSH Route 41). This improvement will improve the traffic conditions as well as the level of service of the intersection. In accordance with NJAC 7:36-26.5, the Township shall provide as compensation for the diversion capital funding dedicated towards future recreation improvements.
