This hearing will be held to solicit comments from the public on the intention of the Board of Chosen Freeholders of the County of Passaic to administratively transfer approximately 13,687 square feet or 0.3142 acres of Green Acres encumbered parkland and maintain an easement of 3,269 square feet or .0750 acres (a portion of Block 81, Lot 1) of Goffle Brook Park, Passaic County-owned parkland immediately adjacent to 1 Downes Way, Hawthorne, NJ 07506 (Block 81, Lot 1) in the Borough of Hawthorne to the adjacent property owner, the Borough of Hawthorne, NJ. The purpose of this proposed administrative transfer is to provide the Borough of Hawthorne ownership of the parcel that is currently being used by the Boys and Girls Club of Hawthorne as a playground with the understanding that the playground will be accessible to the general public. The Green Acres restrictions on the parkland will be transferred with the parkland and will run with the property in perpetuity.

The Borough of Hawthorne, NJ will compensate the County of Passaic \$1.00.
