### PUBLIC HEARING NOTICE

**TAKE NOTICE** the Township of Hopewell is seeking a proposed change in purpose or use on 10 acres of the Alliger Tract which known as Hopewell Township Tax Block 92, Tax Lot 9, 221 Washington Crossing-Pennington Road, Titusville, NJ 08560 (NJDEP Green Acres Project #1106-97-091 and 11-95-24) ) to permit the on-site construction of a building.

The Township proposes to relocate the historic Harts Corner Schoolhouse from the corner of Mercer County Route 546 and Scotch Road to an area on Alliger Park located immediately west of the existing parking lot on Alliger Park. The building will be used for recreation and conservation purposes including meetings, display of historic information, file storage, and other park uses. The building will be modified to include restrooms to be served by an on-site well and septic system.

Pursuant to N.J.A.C. 7:36-25.6(a)1, a hearing to obtain public comment on this proposed change of purpose or use will be held at:
