This Notice is being provided to you as you have been listed as a member of the Green Acres Program regarding the proposed land disposition as set forth more fully herein.

PLEASE TAKE NOTICE that the City of Ventnor has filed a request with the New Jersey Department of Environmental Protection, Green Acres Program, proposing to dispose of 13,222 square feet (approximately .3 acres) of the former Ventnor City Ice Skating Rink. As compensation for the proposed disposal, the City of Ventnor proposes to create an outdoor recreational activity in Ventnor West consisting of Lot 1 in Block 358, Lot 1 in Block 359, Lot 1 in Block 360, Lot 1 in Block 361 and Lot 1 in Block 390.

Pursuant to N.J.A.C. 7:36-26.8(a), a hearing to obtain public comment on this request will be held at Ventnor City Hall, 6201 Atlantic Avenue, Ventnor, New Jersey, on the **18th** day of **October, 2012**, at **6:30 P.M.**
