

## PUBLIC HEARING NOTICE

**Take notice** that the Township of Chatham has filed a request with the New Jersey Department of Environmental Protection, Green Acres Program, proposing to legalize the past diversion of approximately 1,000 sq. ft. of Esternay Park (located on Fairmount Avenue and River Road, Block 62.08, Lot 18 on the Chatham Tax Map) and approximately 1,196 sq. ft. of Colony Pool (located at 55 School Avenue, Block 105, Lot 6 on the Chatham Tax Map) in connection with the placement of temporary wireless communications facilities installed by T-Mobile Northeast LLC. Both facilities were removed in 2018.

As compensation for the past diversions, the Township has accepted payment of \$217,942.98 from T-Mobile Northeast LLC, to be used to purchase an approximately 0.86-acre portion of Block 62, Lots 93 and 94 in the Township of Chatham. These parcels have been dedicated as open space with Green Acres restrictions placed upon them in perpetuity.
