

PUBLIC HEARING NOTICE

Clinton Township is proposing to change the use of a 40+/- acre portion of Block 82, Lots 4 and 4.03 (Marookian property, 139.29 acres) to add a disc golf course to the trails and farming activities at this site more specifically described as follows:

Construction of a disc golf course requiring installation of baskets, previous development of tee pads, light clearing of fairways and clearing of invasive species like Russian olive, multiflora, and Japanese barberry and any other minor construction that may be needed to construct the course. The proposed disc golf course will provide the community a local venue for learning, participating and enjoying this challenging activity.

Pursuant to N.J.A.C. 7:36-25.6(a)1, a hearing to obtain public comment on this proposed change of use will be held on April **28, 2021 at 7:00 p.m.** All interested persons may attend remotely and be heard at the aforesaid hearing. In accordance with the Open Public Meetings Act, NJSA 10:4-6, et seq., and in consideration of the COVID-19 pandemic, the public hearing will only be held electronically and may be accessed through a WebEx video meeting as follows:
