TAKE NOTICE that the County of Monmouth has filed a request with the New Jersey Department of Environmental Protection, Green Acres Program, proposing to add 1.26 acres to Hartshorne Woods Park in the Township of Middletown (Block 786 p/o Lot 2) to compensate for the diversion or disposal of 0.35 acres of the park in Middletown Township (Block 786, p/o Lot 1) to accommodate the proposed Intersection Improvements at CR 8A (Locust Avenue & Valley Drive), CR 8B (Navesink Avenue), Monmouth Avenue, & Oakdale Run.
