**TAKE NOTICE** that the City of Passaic has filed a request with the New Jersey Department of Environmental Protection, Green Acres Program, proposing to transfer ownership of parkland from the City of Passaic, 330 Passaic Street, Passaic, NJ 07055 to the County of Passaic Board of Chosen Freeholders, 401 Grand Street, Rm #220, Paterson, NJ 07505. The parkland to be transferred is known as Dundee Island, Block 1001.03, Lot 1 and Block 1017, Lot 20, consisting of 7.4 acres or approximately 320,775 square feet and is subject to Green Acres restrictions. The Green Acres restrictions on the parkland will be transferred with the parkland and will run with the property in perpetuity.
