November 20, 2012

Chairman Sarnas called the meeting to order at 10:00 a.m.

During the discussion Mrs. Semple noted that in her report from October, when discussing the acceptance of commercial laboratory reports, that the availability of cerebrospinal fluid (which is tested at the PHEL) will be used to discriminate both confirmed and probable cases. FINANCIAL STATEMENT

The financial statement was distributed and reviewed. The October payment was made for the toll-free number. The Secretary also noted that all program line-item funds have either been encumbered or spending plans approved. Mr. Mayer moved and Mr. Emerson seconded a motion to approve the financial statement. All members approved.

REPORT FROM THE SECRETARY

Mr. Kent reported that on October 15, the Governor sent his condolences to former Commissioner Chairman, Dr. Len Spiegel's family. The Secretary noted that last month he was asked to update the status of the members. There were several interesting articles distributed to the members.

REPORT FROM THE TECHNICAL ADVISOR

Ms. O'Malley stated that SMCC # 11 the Koehring hydraulic excavator assigned to the Division of Fish & Wildlife's Bureau Land Management and usually housed at the Hackettstown Hatchery, was temporarily transferred from the Hatchery to the Southern Region immediately following Hurricane Sandy. The excavator was needed to install a new culvert in the Tuckahoe WMA, to temporarily repair a breach in an impoundment on the Wildlife Management Area. The November 13th new moon tide had reopened the breach. The Marsh Master was also being utilized by the Bureau of Land Management for some storm cleanup work also in the Southern Region. This equipment was returned to the Forest Fire Equipment Maintenance Yard in Mays Landing on November 19th and is being picked up by the Morris County Mosquito Commission on November 20th for work in that county.

COMMITTEE REPORTS

Legislative – No report.

Equipment – Mr. Petrongolo stated that the Warren County Mosquito Control Commission has requested that the State Commission replace a county-owned insecticide application machine. The Equipment Committee recommended that it be ascertained if the Warren County Mosquito Control Commission first approached their own county administration with this request, as per SMCC policy. That issue notwithstanding, the SMCC does not have the funds for this purchase. The committee recommended denial of the request. All members approved; Mr. Emerson abstained.

Research and Development – No report.

Budget – Dr. Bruder reported that the committee met several weeks ago; the budget was reviewed and without adjustments some state programs may be adversely affected. The other concern considered by the committee is the attrition of staff within the Office of Mosquito Control Coordination. There was additional discussion with regard to the scheduling of a meeting with DEP Commissioner Bob Martin to discuss these matters.

Public Relations – Mr. Semple stated there will be a meeting in the future.

Ad-hoc County Assistance – Mr. Emerson noted that ad-hoc committees dissolve at the end of the business year. The ad-hoc committee can be reestablished next year, if necessary.

DEPARTMENT OF HEALTH

Shereen Semple reported that she needs to continue reviewing records and documents before she offers an end-of-the-year report. Some human cases of West Nile virus still require confirmation.

DEPARTMENT OF AGRICULTURE

Mark Mayer stated that copepod production is at maintenance levels. The PHEAL building had some damage from the storm "Sandy." No gypsy moth program is planned next year because there are no discovered egg masses. There was also minor damage at the Beneficial Insect Laboratory from the recent storm.

NEW JERSEY AGRICULTURAL EXPERIMENT STATION

Dr. Reed noted that she finished two reports to close out the end of the year. She will prepare a presentation for the upcoming AMCA conference. A calibration for light traps session is planned. Mrs. Semple noted that during the recent storm, the Health Department's "storm center" was referring to documents used last year during Hurricane "Irene". There were references in the documents to mosquito awareness.

ASSOCIATED EXECUTIVES OF MOSQUITO CONTROL WORK IN NEW JERSEY

Dr. Williams reported that due to the storm "Sandy" they had cancelled the meeting and rescheduled it for December 5, at the NJDEP, Assunpink Wildlife Management Area.

OLD BUSINESS

Mr. Emerson inquired about attendance at the AMCA. The Secretary advised that a request to attend must be submitted through the DEP Administration.

NEW BUSINESS

Future meeting sites were considered at the PHEAL, Eco-Center and elsewhere.
