

Welcome to the Thomas F. Breden Preserve at Milford Bluffs

The New Jersey Natural Lands Trust manages the 264-acre preserve positioned on the top of red shale cliffs overlooking the Delaware River. Named for Thomas F. Breden, a former Administrator of the NJ Office of Natural Lands Management and former Executive Director of the NJ Natural Lands Trust, the preserve embodies his devotion to conservation.

This Preserve is a mixture of forest and grassland field habitats; home to rare plants and breath-taking views of the Delaware River valley. Under management of the NJ Natural Lands Trust, sustainable farming practices carried out by a local farmer provide habitat for grassland birds while offering visitors open views across the Bunn Valley region of Holland Township.

Thomas F. Breden Preserve Rules: This preserve is an important habitat for native plants and wildlife. The following rules will help ensure its natural integrity for future generations.

- * The preserve is open during daylight hours for nature study and passive recreation.
- * Trout fishing is welcomed along the Hakihokake Creek near Route 519.
- * The Natural Lands Trust allows deer hunting at this preserve by permit. For information about obtaining a hunting permit, please go to www.njnl.org.
- * Pets must be kept on a leash. Please clean up after your pets.
- * Alcoholic beverages, camping, fires, littering & motorized vehicles are prohibited.
- * Protect the plants you see. Some of them are rare.
- * Do not disturb the agricultural hay fields.
- * Be considerate of neighboring private properties.

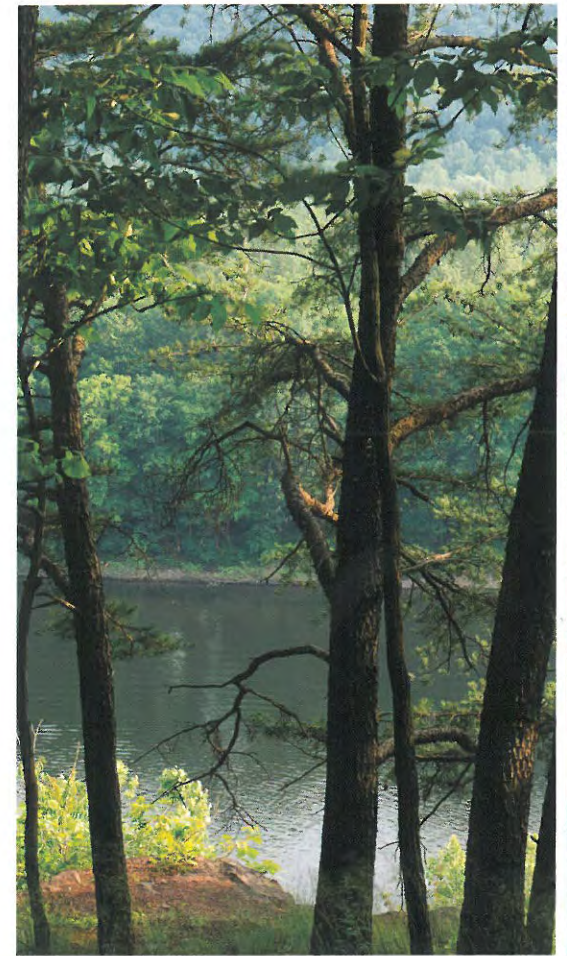
Directions: Driving north on Route 519 from the town of Milford, New Jersey, visitors should look for the Thomas F. Breden at Milford Bluffs roadside sign. Turn left on a narrow dirt drive 1.25 miles north of the intersection of Route 519 and Bridge Street in Milford. Once on the drive, parking and a trailhead are found on the left.

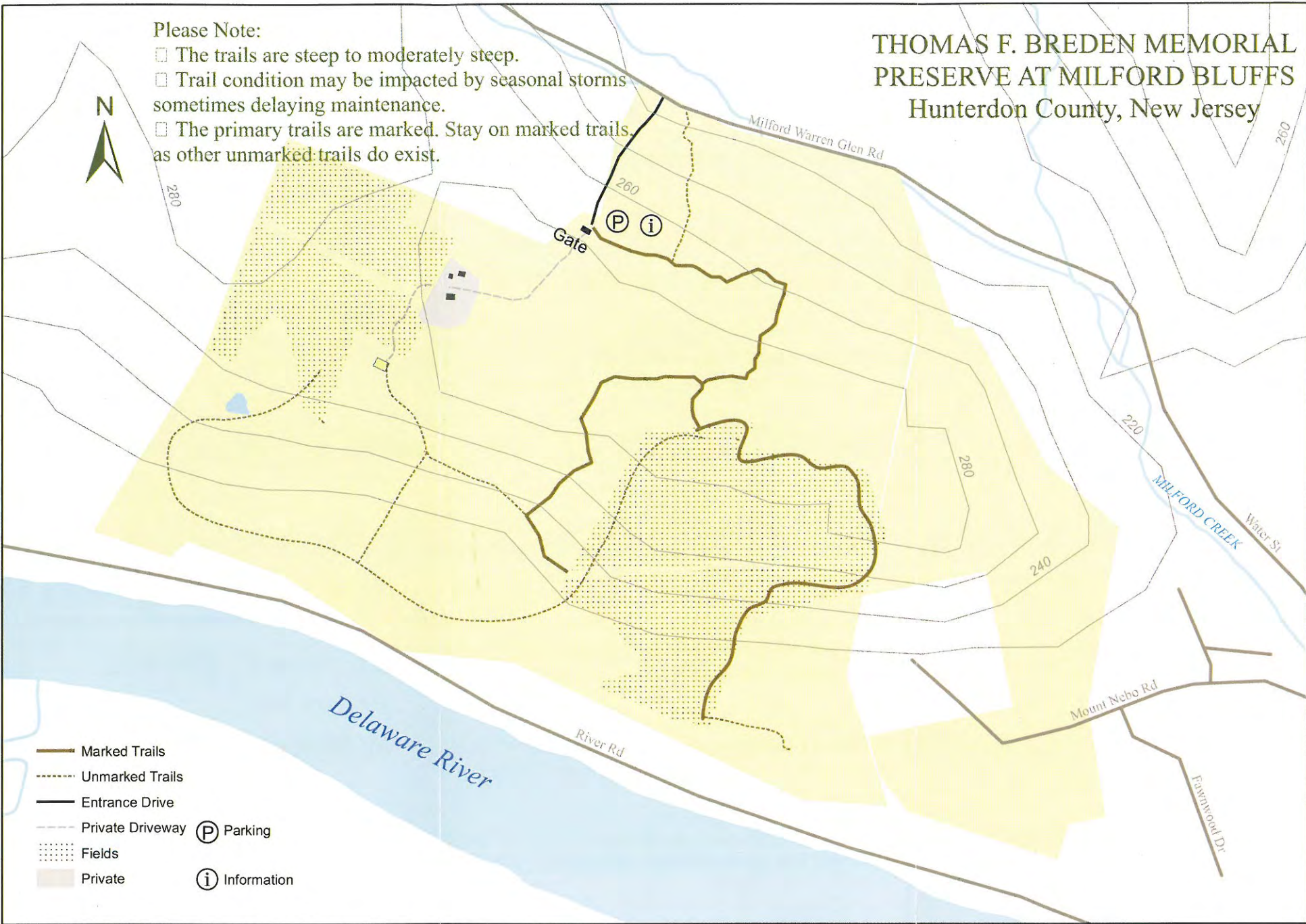
