Owner of equipment from which the discharge occurred:

The owner of the equipment which was the source of the release is not known.

Describe Incident:

On June 8, 1999 at approximately 8:00 a.m., the Quala Systems, Inc. facility manager discovered a 10 by 5 feet stained area in the parking lot of the facility. The only vehicles present in the area were clean trailers, so the exact source of the discharge is unknown. The amount spilled was estimated at approximately 30 gallons. Impacted soils were excavated from the area and placed in four metal 55 gallon drums. All cleanup activities were completed at approximately 11:30 a.m. The spill was reported to the New Jersey Department of Environmental Protection on June 8, 1999 at approximately 1:00 p.m.

Source and Location of Discharge:

The source of the discharge was most likely a tanker trailer. The location of the discharge was the parking area of the facility.

Portions of the Quala Systems, Inc. facility are located in the City of Newark in Essex County, Block 5011, Lot 1.

Material Released:

Approximately thirty gallons of an oil like substance was released. The material is currently being characterized and will be properly disposed.

Discovery and Notification of Release:

The release was discovered by the QSI facility manager on June 8, 1999 at approximately 8:00 a.m. The exact time of the spill is not known, but mostly likely occurred the previous night. The spill was reported to NJDEP at 1:00 p.m. on June 8, 1999 and assigned number 99-06-08-1307-22 by operator 2.

Response Measures Taken:

Impacted soils were excavated from the discharge area using a back hoe and placed into four metal 55 gallons drums. The area was regraded after the excavation was completed. The drums were placed on the drum storage pad pending waste characterization and disposal approval.

Cleanup Contractors:

The spill was cleaned up by onsite QSI personnel.

Countermeasures Taken:

A notice is conspicuously posted at the facility stating that any intentional discharge of material to the yard will result in prosecution, and any accidental discharge to the yard should be immediately reported to the management. Tenants were informed of the spill.

Certification:

"I certify under penalty of law that the information provided in this document is true, accurate and complete. I am aware that there are significant civil and criminal penalties, including fines or imprisonment or both, for submitting false, inaccurate or incomplete information."
