The New Jersey Department of Environmental Protection (Department) is readopting without amendments the Dam Safety Standards at N.J.A.C. 7:20. The Dam Safety Standards implement the Safe Dam Act, N.J.S.A. 58:4-1 et seq. and govern the design, construction, inspection, operation, maintenance, modifications and repair of dams in New Jersey which raise the water height of a stream by more than five feet. Certain dams in the pinelands area are exempt from these rules so long as they do not pose a security or safety concern (see N.J.S.A. 58:4-1). The primary objective of these rules is to ensure the protection of areas below dams from the consequences of their
