### ADMINISTRATIVE ORDER NO. 2010-05

WHEREAS by Administrative Order No. 2009-05, signed on May 28, 2009, then-Acting Commissioner Mark N. Mauriello convened the New Jersey Department of Environmental Protection (NJDEP) Science Advisory Board (SAB) and four standing committees to the SAB; and

WHEREAS the Department has spent the last ten months implementing the selection process for appointments to the Board as required in paragraphs 15-18 of Administrative Order 2009-05 by issuing a public solicitation that included: a press release and an announcement of the solicitation on the Department website on June 23, 2009; letters sent statewide to university presidents, academic scientists, and scientists from other institutions, as well as notification to other state and federal agencies during the month of June 2009; and

WHEREAS, the Department received nominations and applications for membership on the SAB and/or its Standing Committees from an impressive and highly respected group of scientists from academia, non-profits and industry; and

WHEREAS the NJDEP Office of Science, in consultation with a panel of other scientists from within the Department, reviewed each applicant's credentials and relevant experience in order to make recommendations to me regarding those candidates that would provide appropriate experience and scientific rigor for the SAB and its Standing Committees to meet the expected needs of the Department; and

WHEREAS Administrative Order 2009-05 requires that the Commissioner shall appoint the members of the SAB and standing committees and that such appointment shall be made by Administrative Order,

NOW THEREFORE, I, Bob Martin, Commissioner of the New Jersey Department of Environmental Protection, by virtue of the authority vested in me by N.J.S.A. 13:1B-3, do hereby Order and Direct that the following individuals are appointed to the NJDEP Science Advisory Board and its Standing Committees named Ecological Processes, Climate and Atmospheric Sciences, Public Health and Water Quality and Quantity. I further order and direct that the chairpersons of the four standing committees shall also serve on the SAB. No other member of the standing, ad hoc or subcommittees shall serve on the SAB.
