From Route 1 S/North Jersey - Rt. 1 S to Rt. 129, S. Broad St./Chambersburg exit. Take Rt. 129 to the 2nd light Cass St. Turn right onto Cass St. Go through 3 lights & Riverview plaza/Stadium is on the left.

From Route 295 North/South Jersey - Rt 295 N to Exit 60 for 195/29/129. After exiting stay left and follow signs for Rt. 29 N. Stay left and follow signs for 29 N/Capital Complex/Lambertville. Riverview Plaza/Stadium is on the left after exiting tunnel.

From NJ Turnpike Exit 7A - Take interstate 195 W toward Trenton to Rt. 29 N. Stay left and follow signs for 29 N/Capital Complex/Lambertville. Riverview Plaza/Stadium is on left after exiting tunnel.

From Route 1 North/PA - Interstate 95 N to Rt. 1 N. Take first exit in NJ for Rt. 29. Take 29 S, follow signs for parking, Riverview plaza/Stadium is on the right.

* Parking

Use the parking garage, which is in front of Riverview Plaza. Riverfront Stadium is a very short walk from the location of the Mayors Roundtable. You can leave your car in the parking garage during the ballgame. KatManDu, a riverfront restaurant, is also close to the parking garage.
