What's Been Updated

- Cases qualifying for 1-year extension to their regulatory timeframe (Statutory and extended Statutory RI cases)
- Cases qualifying for a 270-day extension to their regulatory timeframe (Regulatory timeframes due between March 9th, 2020 and February 1st, 2021, and no retained LSRP)
- Cases qualifying for a 455-day extension to their regulatory timeframe (Regulatory timeframes due between March 9th, 2020 and January 10th, 2022 and LSRP retained)
 - And all subsequent regulatory timeframes

What Hasn't Been Updated Yet

- x Cases that only qualify for an extension of a mandatory timeframe.
 - For example, a case with a 4/15/2019 Regulatory and 4/15/2021 Mandatory timeframe would qualify for an extension to the Mandatory timeframe only.
