#### LSRP Continuing Education Requirements



36 Continuing Education Credits (CECs) over 3 year LSRP license renewal period:

Minimum no. of CECs must be satisfied in these categories:

- 3 CECs Ethics
- 10 CECs Regulatory
- 14 CECs Technical
  - +9 CECs Discretionary

Board can require "CORE" courses

#### Continuing Ed Credits (CECs)



- One CEC is equivalent to 1 hour of instruction from university, college, DEP, LSRPA & other professional organizations
- Conferences Conventions Workshops 1hr = ½CEC
  - Up to 8 CECs allowed within 3 year renewal cycle
  - Changes to this policy are up to discretion of LSRP Board
- Webinar and On-Line Courses: CEC is 1:1 but exam is required
- CECs available for presentations, publications but not 1:1 credit 5

- Identify the current case status
- Summarize the work completed and planned for each AOC





# Why Change?

- To incorporate "lessons learned" from 3 years in LSRP Program
- To upload with ePortal submissions
- To provide more consistent reporting using dropdown lists
- To reduce the need for narrative in the Activity Column





# What's Changed?

- The AOC spreadsheet has been expanded
- More specific information requested
- Most fields use dropdown lists
- Less narrative needed in the Activity column

7		<b>Dec. 2009 RAR</b> - Soil contamination (TCE) was detected above the soil standards. Soil source of TCE was excavated and post-ex results below the Soil Standards. TCE and daughter products detected in GW. GW contamination is off-site and was delineated horizontally and vertically. Contamination shows diving plume. On-site both shallow (15') and deep (75') overburden were contaminated. Off-site, only the deep overburden was contaminated. On-site contamination was remediated to the GWQS. Off-site contamination was monitored for two years. Levels have decreased and decreasing trend is evident. Passes Mann-Whitney. GW RAP application submitted. Once issued, a Limited Restricted Use RAO-A will be issued.
