## Delegation, Authorization, and Assumption Under the Waiver Rule

N.J.A.C. 7:1B (Waiver Rule) prohibits the Department from waiving rules under certain circumstances. The Waiver Rule at N.J.A.C. 7:1B-2.1(b)2 provides that a waiver shall not be issued in the following circumstance:

A rule providing for a Federally delegated, authorized, or assumed program where the waiver would not be consistent with New Jersey's delegation, authorization, or assumption of authority pursuant to a Federal program.

Many of the Department's rules are adopted as part of regulatory programs intended to implement federal law through a delegation, authorization, or assumption agreement. A waiver may be approved under these programs so long as the Department's decision is consistent with the particular delegation, authorization, and assumption agreement. Applicants for waivers under these programs should be mindful of these facts and may want to submit a short analysis explaining why approving a waiver for a particular program rule would not violate N.J.A.C. 7:1B-2.1(b)2.

Further, the Department is prohibited from waiving rules implementing a State Implementation Plan adopted pursuant to the Federal Clean Air Act. The Waiver Rule provides at 7:1B-2.1 (b)3 that a waiver shall not be issued for:

A rule that implements a Federally enforceable program pursuant to a State Implementation Plan (SIP), as defined at N.J.A.C. 7:27-18.1.
