Appendix A contains a table which details the certification exams and experience requirements per license type. All well driller and pump installer applications must be reviewed by the New Jersey State Well Drillers and Pump Installers Examining and Advisory Board (Board). The Board meets six times per year and has conference calls on the off months to certify license applicants.

Once the Board reviews the applications, a staff member from the New Jersey Department of Environmental Protection (Department) will contact you and notify you of the status of your application.
