REVISION TO THE CAPE MAY COUNTY, LOWER DELAWARE, MERCER
COUNTY, MONMOUTH COUNTY, NORTHEAST, SUSSEX COUNTY, TRI-
COUNTY, AND UPPER RARITAN WATER QUALITY MANAGEMENT
PLANS

TAKE NOTICE that on OCT 01 2007 pursuant to the provisions of the Water Quality Planning Act, N.J.S.A.58:11A-1 et seq, and the Statewide Water Quality Management Planning rules, N.J.A.C. 7:15-3.5, a revision to the Cape May County, Lower Delaware, Mercer County, Monmouth County, Northeast, Sussex County, Tri-County, and Upper Raritan Water Quality Management (WQM) Plans was adopted by the Department. This revision will update the digital sewer service area (SSA) mapping adopted on October 11, 2006 to correct minor errors within the mapping so that it is consistent with the appropriate adopted Areawide Water Quality Management Plans (WQMP) and Wastewater Management Plans (WMP) per N.J.A.C. 7:15-3.5(b)1.

Within the Cape May County WQM Planning Area in West Cape May Borough, Cape May County, a correction has been made to correctly identify the boundaries of the SSA of the Cape May Regional Wastewater Treatment Plant (NJ0020371). These areas were identified in a revision to the Cape May County WQM Planning area that was adopted July 11, 2006.

Within the Lower Delaware WQM Planning Area in Pennsville Township, Salem County a correction has been made to add areas to the SSA of the Pennsville Township Municipal Utilities Authority (MUA) Sewage Treatment Plant (STP) (NJ0021598). These areas were identified in a revision to the Lower Delaware WQM Planning area that was adopted March 23, 2000.

Within the Lower Delaware WQM Planning Area in Oldmans Township, Salem County a correction has been made to add areas to the SSA of the Carney's Point Sewerage Authority STP (NJ0021601). These areas were identified in an amendment to the Lower Delaware WQM Planning area that was adopted July 9, 2001.

Within the Mercer County WQM Planning Area in the Townships of Ewing, Hopewell and Lawrence, Mercer County a correction has been made to correctly identify the SSA of the Ewing-Lawrence Sewage Authority (ELSA) STP (NJ0024759) as depicted in the Mercer County WQMP.

Within the Mercer County WQM Planning Area in the City of Trenton, Mercer County a correction has been made to identify the designated SSA as the City of Trenton Wastewater Treatment Plant (NJ0020923).

Within the Mercer County WQM Planning Area in Hopewell Township, Mercer County a correction has been made to include a designated discharge to ground water (DGW) service area. The Hopewell Town Center has an approved planning flow of 0.013 mgd as identified in an amendment to the Mercer County WQM Planning area that was adopted November 7, 1996.

Within the Mercer County WQM Planning Area in Hopewell Township, Mercer County a correction has been made to include a designated DGW service area. The Hopewell Township Municipal Complex (NJG0147656) has an approved planning flow of 0.011 mgd as identified in the Hopewell Township WMP that was adopted March 26, 1991.

Within the Mercer County WQM Planning Area in Washington Township, Mercer County a correction has been made to add Block 23, Lot 2 (Sharon Elementary School) to the SSA of the Hamilton Township Water Pollution Control Facility (NJ0026301) as identified in an amendment to the Mercer County WQM Plan that was adopted December 10, 1997.

Within the Monmouth County WQM Planning area in Millstone Township, Monmouth County a correction has been made to include a designated DGW service area. The Millstone Township Middle School (NJ0162591) has an approved planning flow of 16,850 gallons per day (gpd) as identified in an amendment to the Monmouth County WQM Plan that was adopted September 7, 2006.

Within the Northeast WQM Planning Area in New Providence, Union County a correction has been made to include Murray Hill Farms to the SSA of the New Providence STP (NJ0021636) as identified in the New Providence WMP adopted May 5, 1994.

Within the Northeast WQM Planning Area in Jefferson Township, Morris County a correction has been made to correctly identify the SSA of the Seneca Garden Apartments (NJ0065820) as identified in a revision to the Jefferson Township WMP adopted October 19, 1995. In addition, areas that were previously labeled Seneca Garden Apartments but are not part of the complex are correctly relabeled General with a DGW less than 20,000 gpd.

Within the Sussex County WQM Planning Area in Hampton Township, Sussex County, the area misidentified as the McKeown Elementary School (NJ0083402) has been returned to its designation as a DGW Less than 20,000 gpd. The McKeown Elementary school has been returned to its correct location.

Within the Sussex County WQM Planning Area in Andover Township, Sussex County a correction has been made to return areas that were incorrectly identified as DGW Less than 20,000 gpd to their correct designation as General Service Areas for Wastewater Facilities with Planning Flows Less than 2,000 gpd Which

Discharge to Ground Water as stated in the Sussex County-Wide WMP adopted December 14, 2001.


Within the Sussex County WQM Planning Area in Andover Borough, Sussex County a correction has been made to correctly identify the boundary for the Sussex Properties, Inc. WWTP (NJ0134490) that was adopted in the Sussex County-Wide WMP December 14, 2001.

Within the Sussex County WQM Planning Area in Hampton Township and Frankford Township, Sussex County a correction has been made to correctly identify the SSA of the Sussex County Homestead Complex (NJ002063) as identified in a revision to the Sussex County WQMP adopted September 11, 2006. In addition, areas that were previously labeled Sussex County Homestead Complex but are not part of the complex are correctly relabeled General with a DGW less than 20,000 gpd.

Within the Tri-County WQM Planning Area a correction has been made to the Archway School site which straddles the border between Waterford Township, Camden County and Evesham Township, Burlington County. The entire school site is served by the Camden County Municipal Utility Authority (CCMUA) Delaware #1 Water Pollution Control Facility (WPCF) (NJ0026182). The CCMUA WMP which correctly identifies this area was adopted April 8, 1999.

Within the Upper Raritan WQM Planning Area in Clinton Township, Hunterdon County a correction has been made to reflect the approved proposed planning flow of 0.0066 mgd for the Arrow Mill Plaza DGW STP (NJ0067229) that was adopted in the Clinton Township WMP September 26, 1991.

A correction to the NJPDESFL field in the SSA attribute table has been made to reflect the current NJPDES permitted flow rates.
