REVISION TO THE LOWER RARITAN/MIDDLESEX, NORTHEAST, MERCER COUNTY,
SUSSEX COUNTY, AND UPPER RARITAN WATER QUALITY MANAGEMENT PLANS

TAKE NOTICE that on _____ pursuant to the provisions of the Water Quality Planning Act, N.J.S.A.58:11A-1 et seq, and the Statewide Water Quality Management Planning rules, N.J.A.C. 7:15-3.5, a revision to the Lower Raritan/Middlesex, Northeast, Mercer County, Sussex County and Upper Raritan Water Quality Management (WQM) Plans was adopted by the Department. This revision updates the digital sewer service area (SSA) mapping to identify Sanitary Subsurface Sewage Disposal System General Permit (T-1 Permit) wastewater treatment facilities and other wastewater treatment facilities existing at the time of the most recently adopted Areawide Water Quality Management Plans (WQMP) and Wastewater Management Plans (WMP) per N.J.A.C. 7:15-3.5(b)1i.


