(each less than 2,000 gpd), one servicing Guiseppe's Restaurant, and another servicing the remaining four shops. Guiseppe's Restaurant is expanding to include the adjacent vacant shop. The new flow for this facility including the previous and expanded restaurant is proposed at 4,025 gallons per day. No changes are proposed to the building or parking footprints. Guiseppe's Restaurant is located on Block 453, Lot 178.03 Upper Township, Cape May County. Guiseppe's Restaurant is located on the eastbound side of Rt. 50, near the junction of Rt. 50 and Hope Corson Road. The proposed project is in the Seaville coastal center.

Executive Order No. 109 (2000) and N.J.A.C. 7:15-5.18,

Environmental review policies, are addressed as follows:

1. Consumptive Water Use—Potable water supply will come from an on-site well in the Cohansey aquifer. All wastewater will be discharged on-site via groundwater disposal. No irrigation system is currently utilized or proposed, all newly constructed faucets and toilets will be of a water conserving type;

2. Stormwater—No stormwater infrastructure exists or is proposed, all stormwater runoff will be recharged on-site, no additional imperious

cover is proposed.

3. Wetlands/Riparian Corridor—No construction in streams,

wetlands or wetland buffers is proposed;

4. Wastewater Disposal to Groundwater—Impacts of groundwater discharge will be evaluated by the Department's NJPDES permit review process.

Upon review of the application submitted, the Department believes that the above-mentioned design considerations and methods proposed for the project adequately address the required environmental analyses.

This amendment represents only one part of the permit process and other issues may need to be addressed prior to final permit issuance. Additional issues which may need to be addressed may include, but are not limited to, the following: antidegradation; effluent limitations; water quality analysis; exact locations and designs of future treatment works (pump stations, interceptors, sewers, outfalls, wastewater treatment plants); and development in wetlands, flood prone areas, designated Wild and Scenic River areas, or other environmentally sensitive areas which are subject to regulation under Federal or State statutes or rules.

# Adopted Amendment to the Cape May County Water Quality Management Plan Public Notice

Take notice that on June 24, 2002, pursuant to the provisions of the New Jersey Water Quality Planning Act, N.J.S.A. 58:11A-1 et seq., and the Statewide Water Quality Management Planning rules (N.J.A.C. 7:15-3.4), an amendment to the Cape May County Water Quality Management Plan (WQMP) was adopted by the Department of Environmental Protection (Department).

This amendment, to accommodate proposed changes to a campground/recreational facility known as Lake and Shore Resort, was proposed on May 6, 2002, at 34 N.J.R. 1745(a). No comments regarding the proposed amendment were received during the comment period.

This amendment has been approved to allow the existing Lake and Shore Resort facility to increase on-site groundwater discharge from 62,250 gallons per day (gpd) to 143,000 gpd. The public notice contained a typographical error indicating a proposed flow of 140,000 gpd. The proposed additional flow will result from the addition of 372 campsites (trailer), 4,000 square feet of maintenance and housekeeping space, 10,630 square feet of amenity space, three comfort stations and a 1,200 square foot swimming pool. All new trailer campsites, buildings and amenities will be located within the existing property boundaries. Lake and Shore Resort facility is located on Block 224, Lots 72 and 79, in Dennis Township, Cape May County. The facility is located on the southbound side of Corson's Tavern Road just north of Woodbine-Oceanview Road (Rt. 550). This facility is located in a Planning Area 4 (Coastal Rural). CAFRA permit #0504-90-0015.5 was approved on July

22, 1999, and requires deed restrictions on wetlands and forested areas of this site to preserve and protect Critical Wildlife Habitat and Threatened and Endangered Species Habitat.

Executive Order No. 109 (2000) and N.J.A.C. 7:15-5.18, Environmental review policies, are addressed as follows:

- 1. Consumptive Water Use—Potable water supply will come from on-site wells in the Cohansey aquifer. All wastewater will be discharged on-site via groundwater disposal. No irrigation system is currently utilized or proposed, all newly constructed faucets, showers and toilets will be of a water conserving type;
- 2. Stormwater—No stormwater infrastructure exists or is proposed, all stormwater runoff will be recharged on-site. Clearing of native vegetation will be minimized, all roads will be gravel, any plantings will be native drought resistant species;
- 3. Wetlands/Riparian Corridors—No construction in streams, wetlands or wetland buffers is proposed, these areas are required to be deed restricted as per CAFRA permit #0504-90-0015.5, approved on July 22, 1999;
- 4. Wastewater Disposal to Groundwater—The facility currently has a NJPDES groundwater discharge permit (#0087734) approved for 61,920. Impacts of additional groundwater discharge will be evaluated by the Department during the NJPDES permit modification review.
- 5. Threatened and Endangered Species Habitat—CAFRA permit #0504-90-0015.5 was approved on July 22, 1999, and requires deed restriction on wetlands and forested areas of this site to preserve and protect Critical Wildlife Habitat and Threatened and Endangered Species Habitat.

Upon review of the application submitted, the Department believes that the above-mentioned design considerations and methods proposed for the project adequately address the required environmental analyses.

This amendment represents only one part of the permit process and other issues may need to be addressed prior to final permit issuance. #### Adopted Amendment to the Northeast Water Quality Management Plan Public Notice

Take notice that on June 24, 2002, pursuant to the provisions of the New Jersey Water Quality Planning Act, N.J.S.A. 58:11A-1 et seq., and the Statewide Water Quality Management Planning rules (N.J.A.C. 7:15-3.4), an amendment to the Water Quality Management Plan was adopted by the Department of Environmental Protection (Department).

This amendment, submitted on behalf of the Borough of Kinnelon, in Morris County, modifies the Pequannock, Lincoln Park and Fairfield Sewerage Authority (PLPFSA) Wastewater Management Plan (WMP) and the Pequannock River Basin Regional Sewerage Authority (PRBRSA) WMP. This amendment removed 521 acres of Kinnelon Borough from the future Sewer Service Area (SSA) of the PLPFSA's Two Bridges Sewerage Treatment Plant (STP). This plant discharges to the Pequannock River. The 521 acres includes most of the area south and east of Tintle Road. Kinnelon wanted to clarify that this area is not planned for sewer service. The only lots and blocks in this area remaining in the SSA are Lots 403 and 403.01, Block 34, Lots 5, 6 and 7, Block 86 and Lots 84 and 85, Block 86. The removed area now designated for Individual Subsurface Sewage Disposal System, is mostly zoned residential. This removal of land from the SSA, would reduce the total projected flow to the Two Bridges STP by 110,000 gallons per day (gpd) or from 3.27 to 3.16 million gallons per day (mgd).

This amendment was proposed in the New Jersey Register on August 20, 2001 at 33 N.J.R. 2919(b). No comments were received by the Department in response to this notice. This amendment was evaluated in accordance with Executive Order No. 109 (2000) and N.J.A.C. 7:15-5.18 and, due to the nature of the amendment, no environmental analyses were required.

The Pinelands Commission was originally scheduled to receive a report on the petition from the Commission's Executive Director and take action on the petition at its meeting of July 12, 2002. The Commission and the petitioner have agreed that this process should be delayed for one month to provide an opportunity for discussion of the requested amendments and to allow the petitioner sufficient time to prepare a response to the Executive Director's recommendation for denial of the petition. As a result of this request, the Commission will not be asked to take action on the petition until its meeting of August 9, 2002.

## JUVENILE JUSTICE COMMISSION Notice of Availability of Local Level Training Funds

Take notice that the Office of Program Development and Prevention Services announces the availability of \$40,000 in FFY '99 and FFY '00 Juvenile Justice and Delinquency Prevention (JJDP) Formula Grant funds to be used to conduct local level training initiatives. Please note that State agencies are not eligible to apply for these funds.

The primary focus of these funds is to enhance the capacity of youth-serving personnel at the local level to work more effectively with delinquent and/or at-risk youth. Priority consideration will be given to applicants who request funding to enhance staff's ability to engage parents as partners in the ongoing rehabilitation or development of their children; to develop collaborative efforts to address the employment and/or higher education needs of delinquent or at-risk youth; to conduct cultural diversity training designed to reduce the disproportionate

confinement of minority youth; or to disseminate information on the availability of programs and services for girls with the goal of reducing the number of young women entering the juvenile justice system in New Jersey.

Training should be targeted to direct service providers as well as administrators. The development of inter-disciplinary training teams (representing juvenile justice, human services, education, labor, the faith community, consumers and local business/industry leaders) is strongly encouraged. The establishment of regional teams (especially in the less populated areas of the State) also is encouraged.

Applications must be limited to six double-spaced pages and must include the following information:

- · A brief statement of the need to conduct the specified training;
- An outline of the training curriculum/workshop topic(s);
- Goals, objectives and anticipated outcomes of the training;
- Who will be trained and the anticipated number of participants;
- Number of days of training and anticipated date(s)/location(s) of training;
- What agency/organization will be primarily responsible for implementing the training;
  - · Resumes/biographies of trainers; and
  - · A detailed line item budget and narrative.

Awards will range from \$3,000 to \$10,000 with the larger amounts reserved for trainings to be conducted on a regional or even Statewide basis. Funding will be limited to direct training costs (instructors, printing, supplies, subsistence, facility rental, etc.). The Federally established rate for instructors fees is \$450.00 per day for a full eighthour day. Funds cannot be used to cover planning costs or those associated with the development of training curricula.

An original and five copies of the application is due to the Office of Program Development and Prevention Services no later than Monday, August 26, 2002, 12:00 Noon. Late or incomplete applications will not be accepted. Applicants will be notified of a decision to fund no later than Friday, September 27, 2002. Funding will be available for the nine month period October 1, 2002 to June 30, 2003. All training related expenditures must be encumbered by September 30, 2003.
