REVISION TO THE MERCER COUNTY, MONMOUTH COUNTY, NORTHEAST,  
LOWER DELAWARE AND TRI-COUNTY WATER QUALITY MANAGEMENT  
PLANS

TAKE NOTICE that on MAR 16 2009 pursuant to the provisions of the Water Quality Planning Act, N.J.S.A.58:11A-1 et seq, and the Statewide Water Quality Management Planning rules, N.J.A.C. 7:15-3.5, a revision to the Mercer County, Monmouth County, Northeast, Lower Delaware, and Tri-County Water Quality Management (WQM) Plans was adopted by the Department. This revision updates the digital sewer service area (SSA) mapping to correct minor errors within the mapping so that it is consistent with the appropriate adopted Areawide Water Quality Management Plans (WQMP) and Wastewater Management Plans (WMP) per N.J.A.C. 7:15-3.5(b)1.

Within the Mercer County WQM Planning Area in Robbinsville Township, Mercer County a correction has been made to expand the Hamilton Township Wastewater Treatment Plant (WTP) (NJ0026301) Sewer Service Area (SSA) to include Block 22, Lot 1 as identified in the Robbinsville WMP adopted November 19, 2008.

Within the Monmouth County WQM Planning Area in Marlboro Township, Monmouth County, a correction has been made to expand the Western Monmouth Utilities Authority Pine Brook Sewage Treatment Plant (STP) (NJ0023728) SSA to include Block 159, Lot 8 based on a Consistency Determination finding pursuant to N.J.A.C. 7:15-4.2(a)2.

Within the Northeast WQM Planning Area in Livingston Township, Essex County a correction has been made to expand the Parsippany-Troy Hills STP (NJ0024970) to include the Rosedale Estates development as identified in an amendment to the Northeast WQMP adopted May 15, 1996. This property was previously incorrectly identified as within the Hanover Sewerage Authority (SA) SSA.

Within the Northeast WQM Planning Area in West Milford Township, Passaic County a correction has been made to correctly identify and expand the West Milford Shopping Plaza STP (NJ0087530) to include the adjacent Block 6701, Lot 13 as identified in an amendment to the Northeast WQMP adopted April 24, 1997. This property was previously incorrectly identified as the West Milford Shopping Center.

Within the Northeast WQM Planning Area a correction has been made to expand the Passaic Valley Sewerage Commissioners (PVSC) STP (NJ0021016) SSA to include the area that was previously identified as North Bergen Municipal Utilities Authority Central WTP SSA as identified in the PVSC WMP adopted December 4, 2006.


Within the Lower Delaware WQM Planning Area in Pennsville Township, Salem County a correction has been made to expand the Pennsville SA STP SSA to include the Warren

Park Estates, Phase 2, development as identified in an amendment to the Lower Delaware WQMP adopted July 7, 2004.

Within the Tri-County WQM Planning Area a correction has been made to add Block 1200.02, Lots 1 and 2 (East Gate Square Commercial Shopping Complex) located in Mount Laurel Township, Burlington County to the SSA of the Moorestown STP (NJ0024996) as identified in an amendment to the Tri-County WQM Plan adopted February 14, 1997. This property was previously incorrectly identified as within the Hartford Road STP SSA.

Within the Tri-County WQM Planning Area in Harrison Township, Gloucester County a correction has been made to correctly delineate the boundaries of the Harrison Township / Mullica Hill STP (NJ0020532) SSA. The Harrison Township WMP that depicts this area was adopted on November 27, 2000.

Corrections to the SSA attribute table have been made to correct/update the WMP, FACNAME, WMPAGCY and NJDPESFL fields to indicate the appropriate plans, facilities, agencies and NJPDES permitted flow rates.
