REVISION TO THE TRI-COUNTY, UPPER DELAWARE AND UPPER RARITAN WATER QUALITY MANAGEMENT PLANS

TAKE NOTICE that on 10 2008 pursuant to the provisions of the Water Quality Planning Act, N.J.S.A.58:11A-1 et seq, and the Statewide Water Quality Management Planning rules, N.J.A.C. 7:15-3.5, a revision to the Tri-County, Upper Delaware, and Upper Raritan Water Quality Management (WQM) Plans was adopted by the Department. This revision will update the digital sewer service area (SSA) mapping adopted on October 11, 2006 to correct minor errors within the mapping so that it is consistent with the appropriate adopted Areawide Water Quality Management Plans (WQMP) and Wastewater Management Plans (WMP) per N.J.A.C. 7:15-3.5(b)1.

Within the Tri-County WQM Planning Area in Chesterfield Township, Burlington County a correction has been made to correctly identify the Sewer Service Area (SSA) of the Albert C. Wagner Youth Correctional Facility (NJ0026719) as depicted in the Chesterfield WMP that was adopted April 28, 1998.

Within the Upper Delaware WQM Planning Area in Alexandria Township, Hunterdon County a correction has been made based upon improved parcel data to correctly identify the SSA of the following Sewage Treatment Plants (STP): Alexandria Field, Alexandria Township Board Of Education - Middle School (NJ0035670), Crescent Hill Estates, Delaware Valley Regional High School, Everittstown, The Hamlet at Alexandria, Industrial/Commercial, Little York, Pittstown, and Sky Manor Airport as depicted in the Alexandria WMP.

Within the Upper Delaware WQM Planning Area in Frenchtown Borough, Hunterdon County a correction has been made based upon improved parcel data to correctly identify the SSA of the Frenchtown Borough STP as depicted in the Upper Delaware WQMP.

Within the Upper Delaware WQM Planning Area in Milford Borough, Hunterdon County a correction has been made based upon improved parcel data to correctly identify the SSA of the Milford Borough STP as depicted in the Upper Delaware WQMP.

Within the Upper Raritan WQM Planning Area in Clinton Township, Hunterdon County a correction has been made based upon improved parcel data to correctly identify the SSA of the following STPs: Rolling Hills of Hunterdon Nursing Home (NJ0087335), Patrick McGerhan Elementary School, Clinton Wellness Center (NJ0143391), and the Arrow Mill (NJ0067229) as depicted in the Clinton WMP.

Within the Upper Raritan WQM Planning Area in Union Township, Hunterdon County a correction has been made based upon improved parcel data to correctly identify the SSA of the following STPs: Milligan Farm (NJ0131725), Fallone Properties/Renaissance @ Union Township (NJ0140287), Union Township School (NJ0024091), Huntersfield (NJ0066061) and the Clinton Block and Supply as depicted in the Union Township WMP.

Within the Upper Raritan WQM Planning Area in Mount Arlington Borough, Morris County a correction has been made to return areas of the Musconetcong STP SSA that were accidentally removed during the last revision to the digital SSA.

A correction to the NJPDESFL field in the SSA attribute table has been made to reflect the current NJPDES permitted flow rates.
