REVISION TO THE ATLANTIC COUNTY, LOWER DELAWARE, MONMOUTH COUNTY, NORTHEAST, OCEAN COUNTY, SUSSEX COUNTY, TRI-COUNTY, UPPER DELAWARE AND UPPER RARITAN WATER QUALITY MANAGEMENT PLANS

TAKE NOTICE that on JUN 08 2010 pursuant to the provisions of the Water Quality Planning Act, N.J.S.A.58:11A-1 et seq, and the Statewide Water Quality Management Planning rules, N.J.A.C. 7:15-3.5, a revision to the Atlantic County, Lower Delaware, Monmouth County, Northeast, Ocean County, Sussex County, Tri-County, Upper Delaware and Upper Raritan Water Quality Management (WQM) Plans was adopted by the Department. This revision updates the digital sewer service area (SSA) mapping to identify Sanitary Subsurface Sewage Disposal System General Permit (T-1 Permit) wastewater treatment facilities and other wastewater treatment facilities existing at the time of the most recently adopted Areawide Water Quality Management Plans (WQMP) and Wastewater Management Plans (WMP) per N.J.A.C. 7:15-3.5(b)1i.


