



CHIEF WARRANT OFFICER FIVE JENNIFFER TOSSAS



Chief Warrant Officer Five Jenniffer Tossas is the State Command Chief Warrant Officer of the New Jersey Army National Guard comprised of more than 6,000 Soldiers.

CW5 Tossas was appointed as the 10th Command Chief Warrant Officer of the New Jersey Army National Guard in January 2025. As the CCWO, she serves as the Senior Warrant Officer Advisor to the Adjutant General of the New Jersey on all matters pertaining to policies, programs, actions impacting the warrant officer cohort, including professional development, promotions, assignments, incentives, morale, discipline, performance, strength, and recruiting programs.

CW5 Tossas enlisted on May 2, 1996. She attended basic training at Fort Leonard Wood, Missouri, and Advanced Individual Training at Fort Jackson, South Carolina, graduating as an Administrative Specialist.

CW5 Tossas served as an Administrative Specialist with the 29th Infantry Division at Fort Belvoir, Virginia, in 1996. While at Fort Belvoir, she rose to the rank of staff sergeant and served as the Senior Human Resources Sergeant with the Operational Support Airlift Agency. CW5 Tossas attended Warrant Officer Candidate School at Fort Rucker, Alabama, and was commissioned in the Adjutant General Corps on March 12, 2004.

CW5 Tossas' previous assignments include serving as the G-1 Senior Human Resource Officer, Joint Base McGuire-Dix-Lakehurst, New Jersey; Officer Personnel Manager, Joint Base McGuire-Dix-Lakehurst, New Jersey; State Equal Employment Manager, Bordentown, New Jersey; Warrant Officer Strength Manager, Recruiting and Retention Battalion, National Guard Training Center, Sea Girt, New Jersey; Human Resources Technician, 103rd Troop Command, Pearl City, Hawaii; Military Personnel Technician, Headquarters and Headquarters Company, 40th Infantry Division, Los Alamitos, California, and Systems Integrator, National Guard Bureau, Arlington, Virginia. Prior to her appointment, CW5 Tossas served as the Deputy Chief of Staff for Personnel, Joint Force Headquarters – New Jersey, Joint Base McGuire-Dix-Lakehurst, New Jersey.
