**TO: ALL INSURERS AUTHORIZED OR ADMITTED TO TRANSACT
PROPERTY/CASUALTY INSURANCE IN NEW JERSEY**

FROM: KENNETH E. KOBYSLOWSKI, COMMISSIONER

**RE: FILING OF PRIVATE PASSENGER AUTOMOBILE, HOMEOWNERS
AND MEDICAL MALPRACTICE LIABILITY REPORTS**

Insurers authorized or admitted to transact property/casualty insurance in this State are required to file various reports within specified timeframes or by specified dates pursuant to various rules and directives from the Department of Banking and Insurance (“Department”). The purpose of this Bulletin is to remind insurers that these reports are due by the dates specified. The reports are as follows (including authority and due date):

I. Private Passenger Automobile Insurance:

- **Annual Premium Survey**
N.J.S.A. 39:6A-23.1; N.J.A.C. 11:3-45; and annual Bulletin
DUE: Annually by September 15
- **Semi-Annual Reports: Personal Injury Protection Medical Expense Limits Report; Limits of Liability Report; Exposures by Territory**
N.J.A.C. 11:3-3A
DUE: Semi-Annually by January 31 and July 31
- **Excess Profit Report**
N.J.S.A. 17:29A-5.6 through 5.16 and N.J.A.C. 11:3-20
DUE: Annually by July 1

II. Homeowners Insurance:

- **Homeowners Market Survey**
N.J.A.C. 11:2-42.10
DUE: Semi-Annually by January 31 and July 31

III. Medical Malpractice Liability Insurance:

- **Physicians and Surgeons Premium Modifiers**
N.J.A.C. 11:27-13
DUE: Semi-Annually by February 1 and August 1
- **Medical Malpractice Liability Reporting for Closed Claims**
N.J.S.A. 17:30D-1 et seq. and N.J.A.C. 11:1-7
DUE: Seven Days after Settlement of Each Claim

Insurers are reminded that the reports are due by the dates specified and that failure to timely file required reports may result in enforcement action pursuant to N.J.S.A. 17:33-2. Insurers also may wish to review the applicable statutes, rules, orders and bulletins as set forth above.
