This matter having been opened by the Office of Consumer Finance within the Division of Banking of the New Jersey Department of Banking and Insurance ("Department") upon information that Comex Trading, Inc. and its owner, Juliano Soares Souza ("Licensee"), at all times relevant to this Consent Order are licensed as a foreign money transmitter pursuant to the New Jersey Money Transmitter Act, N.J.S.A. 17:15C-1 et seq. for which it may have violated certain provisions of the Act; and

WHEREAS IT APPEARS that Licensee may have violated the following:

N.J.S.A. 17:15C-16 e. Suspension or revocation of license

The Department has received information from two of the Licensee's delegates that sixty nine (69) individuals to date have submitted payments to be transmitted totaling \$129,310,67 that have not been paid to their beneficiaries. (See attached Exhibit detailing customer loss)

AND WHEREAS, in the event that the Commissioner issued an administrative Order to Show Cause to Licensee addressing the above-referenced apparent violations, Licensee would be entitled to request a hearing of the matter as a contested case in accordance with the Administrative Procedure Act, N.J.S.A. 52:14B-1 et seq.; and

WHEREAS Licensee understands these rights and has voluntarily waived the right to a hearing on the matters addressed in this Consent Order; and

WHEREAS, without making any admission of liability with respect to any of the apparent violations cited in this Consent Order, Licensee has agreed for purposes of settlement to undertake the following actions: Suspend any future money transmitting activities until it provides the Department with proof of the funding for all the outstanding transaction listed in the attached Exhibit. Agree to promptly fund any subsequent transaction that is identified. Once such evidence is provided and verified, the Department will then decide as to if or when the license suspension will be vacated; and

WHEREAS, without making any admission of liability with respect to any of the apparent violations cited in this Consent Order, Licensee certifies that failure to comply with the terms of this Consent Order, will result in the issuance of an Order to Show Cause to include a monetary penalty and further administrative actions to include a license revocation and bar from future licensure with the Department; and

WHEREAS the provisions of this Consent Order are imposed pursuant to the police powers of the State of New Jersey for the enforcement of the law and regulations and the protection of the public health, safety and welfare, and are not intended to constitute debts which may be limited or discharged in bankruptcy proceedings; and

WHEREAS the parties to this Consent Order have determined that this matter is suitable for resolution upon the consent of the parties and that Licensee and the Department desire to resolve this matter without a hearing or litigation, and for further good cause appearing;

- Suspend any future money transmitting activities until it provides the Department with proof of the funding for all the outstanding transaction listed in the attached Exhibit.
 Agree to promptly fund any subsequent transaction that is identified.
- 2. Licensee certifies that failure to comply with the terms of this Consent Order, will result in the issuance of an Order to Show Cause to include a monetary penalty and further administrative actions to include revocation and bar from future licensure.

Please accept this letter on behalf of the Office of Consumer Finance ("OCF") of the New Jersey Department of Banking and Insurance ("NJDOBI"), which is charged with regulating the industry in which your company is licensed as a foreign money transmitter in New Jersey. Enclosed is a form of Consent Order proposed by the OCF for your prompt consideration as a means to resolve the outstanding regulatory issues set forth therein.

This form of settlement is offered at this time in lieu of a formal administrative action. This offer is time-sensitive. It will expire five (5) days from the date of this letter while allowing you an additional twenty (20) from this same date to provide proof of funding all the outstanding transmittals as provided. This offer shall in no way prejudice the OCF's ability to take appropriate formal administrative action with respect to the issues set forth in the form of Consent Order, in the event that settlement is not reached.
