THIS MATTER having been opened by the Commissioner of the New Jersey Department of Banking and Insurance (“Commissioner”), under authority of N.J.S.A. 17:11-15; and

WHEREAS, on September 23, 2020, the Commissioner issued an Order and Notice of Violation to Respondent, docket number AR20-1501854 (“Order AR20-1501854”); and

WHEREAS, Order AR20-1501854 advised Respondent of its failure to timely file a 2019 annual report, imposed a penalty, and allowed the filing of the annual report by February 1, 2021; and

WHEREAS, the Order AR20-1501854 further provided that in the event Respondent did not file the 2019 annual report by February 1, 2021, Respondent’s license would be revoked and a \$15,000.00 penalty would be imposed; and

WHEREAS, Respondent failed to file the 2019 annual report by February 1, 2021, and Respondent’s license was revoked and a \$15,000.00 penalty was imposed effective February 2, 2021; and

WHEREAS, on February 17, 2021, Respondent filed its 2019 annual report; and

WHEREAS, on March 18, 2021, Respondent appealed Order AR20-1501854 to the Appellate Division of the New Jersey Superior Court, and the appeal was docketed under the docket number A-001927-20T2; and

WHEREAS, on April 12, 2021, Respondent paid \$15,000.00 in full satisfaction of Order AR20-1501854; and

WHEREAS, Respondent agreed to request the dismissal of the pending appeal within five days of the date of this Order; and

WHEREAS this matter should be resolved upon the consent of all parties; and

NOW, THEREFORE, IT IS on this 24 day of June 2021,

IT IS ORDERED that the Department's Order and Notice of Violation AR20-1501854 is hereby amended; and

IT IS FURTHER ORDERED that Respondent's motor vehicle installment seller license, reference number 1501854, is hereby reinstated; and

IT IS FURTHER ORDERED that Respondent shall request the dismissal of the appellate matter, docket number A-001927-20T2, within five days of the date of this Order.


