knowingly provided materially false statements to ESURANCE Insurance Company of New Jersey ("ESURANCE") by failing to disclose that she was involved in an automobile accident prior to adding collision and comprehensive coverage to her ESURANCE automobile insurance policy, and by subsequently stating to ESURANCE that her automobile accident occurred after she obtained collision and comprehensive coverage, when, in fact, her automobile accident occurred before she obtained collision and comprehensive coverage, in violation of the New Jersey Insurance Fraud Prevention Act, N.J.S.A. 17:33A-1 to -30 ("Fraud Act"); and

IT IS FURTHER HEREBY STIPULATED AND AGREED, that Defendant Modafferi's aforementioned conduct constitutes violations of the Fraud Act by Defendant Modafferi, and that any future violation of the Fraud Act by Defendant Modafferi shall be considered a subsequent violation; and

IT IS FURTHER HEREBY STIPULATED AND AGREED, that Defendant Modafferi shall pay a sum of Four Thousand Dollars (\$4,000.00) ("Settlement Amount") to the Acting Commissioner, which consists of civil penalties in the amount of \$2,500.00, pursuant to N.J.S.A. 17:33A-5b; \$1,375.00 in attorneys' fees, pursuant to N.J.S.A. 17:33A-5b; and a statutory fraud surcharge of \$125.00, pursuant to N.J.S.A. 17:33A-5.1; and

IT IS FURTHER HEREBY STIPULATED AND AGREED, that, upon Defendant Modafferi's execution of this Stipulation of Settlement, Defendant Modafferi shall remit to the attorney for the Acting Commissioner the full Settlement Amount, by certified check, official bank check, or money order, made payable to "Acting Commissioner, New Jersey Department of Banking and Insurance" and sent to:

IT IS FURTHER HEREBY STIPULATED AND AGREED, that, in the event full payment of the Settlement Amount is not made, the Acting Commissioner may exercise any and all remedies available by law, including, but not limited to, recovery of any unpaid penalties pursuant to the Penalty Enforcement Law, N.J.S.A. 2A:58-10, et seq.; and

IS FURTHER HEREBY STIPULATED AND AGREED, that the penalties of this Stipulation of Settlement are imposed pursuant to the police powers of the State of New Jersey for the enforcement of the law and protection of the public health, safety, and welfare, and are not intended to constitute debts which may be limited or discharged in a bankruptcy proceeding.
