

THIS MATTER, having been brought by Plaintiff, Richard J. Badolato, Acting Commissioner of the New Jersey Department of Banking and Insurance ("Commissioner"), by way of complaint against Defendant Bruce Buccolo ("Defendant"); and

WHEREAS, a bench trial was held before the Honorable Robert H. Gardner, J.S.C. on March 30, 2016, pursuant to the Insurance Fraud Prevention Act ("Fraud Act"), N.J.S.A. 17:33A-1 et seq.; and

WHEREAS, for the reasons set forth on the record on March 30, 2016, the Court found by trial that Defendant committed one violation of the Fraud Act, pursuant to N.J.S.A. 17:33A-4; and

WHEREAS, the Court awarded the Commissioner civil penalties in the amount of \$5,000.00, attorneys' fees and statutory surcharge pursuant to N.J.S.A. 17:33A-5b and 5.1;

IT IS on this 8 day of april 2016;

ORDERED, that Final Judgment is entered against Defendant Bruce Buccolo and in favor of the Commissioner, in the amount of \$17,337.00, consisting of a civil penalty in the amount of \$5,000.00 for one violation of the New Jersey Insurance Fraud Prevention Act, N.J.S.A. 17:33A-1 et seq.; attorneys' fees of \$11,337.00 pursuant to N.J.S.A. 17:33A-5b; and a statutory surcharge of \$1,000.00, pursuant to N.J.S.A.

ORDERED, that this judgment shall be and hereby is a final judgment in all respects; and it is further

IT IS FURTHER ORDERED, that a copy of this Order be served upon all parties within \_\_\_\_\_ days of counsel's receipt hereof.
