IT IS FURTHER ORDERED that Judgment is GRANTED in favor of Plaintiff, State of New Jersey against the Defendant, Back Pain, P.C. in the amount of \$16,000 for penalties and surcharges under the statute referenced above; and

IT IS FURTHER ORDERED that the New Jersey driver's license of Pedro Gonzalez is suspended for one year from the date of this Judgment pursuant to the above statute; and

IT IS FURTHER ORDERED that the New Jersey driver's license of Awalida D. Gonzalez is suspended for one year from the date of this Judgment pursuant to the above statute; and

IT IS FURTHER ORDERED that Judgment shall also enter against these Defendants for attorney fees and costs in the total amount of \$55,917 also pursuant to the statute and each of these Defendants are jointly liable for this amount; and
