FINAL JUDGMENT is on this 10th day of August 2017, entered in the amount of \$8,005.50 against Defendant Madusu

Kelleh and in favor of the Plaintiff, Richard J. Badolato, the Commissioner of the New Jersey Department of Banking and Insurance. This amount consists of \$5,000.00 in civil penalties, pursuant to N.J.S.A. 17:33A-5b for 1 violation of the New Jersey Insurance Fraud Prevention Act, N.J.S.A. 17:33A-1 to -30 ("Fraud Act"); attorneys' fees of \$2,005.50, pursuant to N.J.S.A. 17:33A-5b; and a statutory fraud surcharge of \$1,000.00, pursuant to N.J.S.A. 17:33A-5.1.\*

IT IS FURTHER ORDERED, that, pursuant to N.J.S.A. 39:6A-15, Defendant Madusu Kelleh's driving privileges will be suspended for a period of 1 year from the date of this judgment.

IT IS FURTHER ORDERED, that a copy of this Order be served upon all parties within 7 days of the date hereof.
