FINAL JUDGMENT is on this day of 2018, entered in the amount of \$18,982.50 against Defendant Soheir Abdeldayem, and in favor of Plaintiff, Marlene Caride, Commissioner of the State of the New Jersey Department of Banking & Insurance. This amount consists of a \$5,000.00 civil penalty pursuant to N.J.S.A. 17:33A-5b for one (1) violation of the Insurance Fraud Prevention Act, N.J.S.A. 17:33A-1 to -30; attorneys' fees of \$12,982.50 pursuant to N.J.S.A. 17:33A-5b; and a statutory fraud surcharge of \$1,000.00 pursuant to N.J.S.A. 17:33A-5.1.
