This amount consists of: \$5,000.00 in civil penalties for five (5) violations of the Insurance Fraud Prevention Act, N.J.S.A. 17:33A-1 to -30; attorneys' fees of \$3,180.00 pursuant to N.J.S.A. 17:33A-5b; \$1,000.00 constituting the surcharge pursuant to N.J.S.A. 17:33A-5.1; and costs of service of process in the amount of \$59.99 pursuant to N.J.S.A. 17:33A-5(b).
